

**OFFICIAL GO ORGANICALLY® FRUIT SNACKS GO GIVES BACK
SWEEPSTAKES RULES: NO PURCHASE NECESSARY TO ENTER OR WIN. A
PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

SWEEPSTAKES PERIOD: “Go Organically® Fruit Snacks GO Gives Back Sweepstakes” (the “Sweepstakes”) begins on 11/01/2017 at 12:00 PM EST and ends at 11:59 PM EST on 11/17/2017 or at another date and time decided solely at the discretion of Go Organically® Fruit Snacks the “End Date”.) The computer clock of the Sponsor is the official time-keeping device in the Sweepstakes.

ELIGIBILITY: The Sweepstakes is open to legal U.S. residents who are 18 years of age or older at time of entry, excluding residents of Puerto Rico and other U.S. territories and possessions. Employees of Promotion In Motion, Inc. (or The Promotion In Motion Companies, Inc.), the makers of Go Organically® Fruit Snacks (“Sponsor”) and their parents, subsidiaries, affiliates, retailers and advertising and promotion agencies (collectively the “Promotion Parties”), and each of their immediate family members (spouse, parent, child or sibling, and their respective spouses, regardless of where they reside) and individuals living in the same households of each of these individuals, whether or not related, are not eligible to enter or win. TO QUALIFY: Beginning Wednesday, November 1st, 2017 at 12:00 PM EST and continuing through the End Date (“Sweepstakes Period”), participants can enter the Sweepstakes by visiting <http://www.gogivesbacksweeps.com/>

Users may enter into the sweepstakes once a day through 11:59 PM EST on 11/17/2017. Calendar day is determined in EST.

TO ENTER: There are two (2) ways to enter the Sweepstakes, as follows:

- a. **VIA TEXT ON THE SITE WITHOUT UPLOADING A PHOTO (TO BE CONSIDERED FOR THE RUNNER UP PRIZE):** During the Sweepstakes Period, you can describe how you have given back/contributed to your community (i.e. non-profit organizations, food drives, local events, kid’s school events, etc) via text entry by visiting <http://www.gogivesbacksweeps.com> (the “Site”) and following the onscreen instructions to complete all required registration information. Entrants with text-only entry will only be considered for the Runner Up Prize.
- b. **VIA TEXT AND PHOTO UPLOAD (TO BE CONSIDERED FOR THE GRAND PRIZE AND RUNNER UP PRIZE):** During the Sweepstakes Period, you can describe how you have given back/contributed to your community (i.e. non-profit organizations, food

drives, local events, kid's school events, etc) via text entry and photo upload by visiting the Site and following the onscreen instructions to complete all required registration information.

c. You can earn one or more bonus entries by completing the following actions on/through the Sweepstakes Entry Page (each, an "Entry Action"):

If you do not have a Twitter or Facebook account, establishing an account is free. All Twitter and Facebook terms and conditions apply (as applicable).

Entries become the property of Sponsor. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any entry, the authorized account holder of the email address connected to the Facebook account that is used to enter will be deemed to be the registrant or player. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address.

Visitors to the Sweepstakes will be asked to fill out the Sweepstakes entry form. If there is a dispute regarding the identity of an Entrant, the holder of the e-mail account will be deemed the person who submitted the entry. Incomplete entries will be disqualified, and Sponsor is not responsible for entries that are lost, late, deleted, garbled, corrupted, misdelivered, or misdirected as a result of technical, internet or other online difficulties or errors. Period. Sponsor is not responsible for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind. The use of automated or third party software or web site to register and/or play is prohibited.

All entry components submitted shall herein be referred to as the sweepstakes entry (the “**Sweepstakes Entry**”). Limit one (1) Sweepstakes Entry per person per day. All Sweepstakes Entries must be completed and submitted by 11:59 p.m. EST on November 17th, 2017, to be eligible. The person uploading the Sweepstakes Entry will be deemed the Entrant (the “**Entrant**”). If submitting a photo depicting other individuals, you must make the other individuals aware that you are entering a photo on their behalf and attest that the other individuals have agreed that you may submit such photo and you must be the parent/legal guardian of any minors featured in the photo. In the event of a dispute as to the identity of an Entrant, the authorized account holder of the email address used to enter will be deemed to be the Entrant. “Authorized account holder” of an email address is defined as the natural person who is assigned to an email address by an Internet Access provider, on-line service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address. The Sweepstakes Entry must: 1) be complete to be eligible; 2) be the property of the Entrant. Any Sweepstakes Entry not in compliance with the above and which does not meet the requirements of these Official Rules will be disqualified. By entering, you understand and agree that your Sweepstakes Entry may (in Sponsor’s sole discretion) be posted online for consumers to view on Sponsor-determined sites. Sponsor reserves the right to remove any posted Sweepstakes Entries, in its sole discretion, even if the Sweepstakes Entry has already been made available to the public. Participation is subject to disqualification of all Sweepstakes Entries, if multiple accounts are used by the same person. As applicable, normal Internet access and data/usage charges imposed by Entrants’ online/mobile service will apply.

WINNER SELECTION: Prize winners will be determined based on random selection, by the Sponsor whose decisions are final in all matters relating to this Sweepstakes and will conduct winner selection and verification. Sponsor will attempt to notify all potential winners by email on or about November 20th, 2017.
